





The Pakistan Telecommunication Authority is pleased to register **Symmetry Group (Pvt.) Limited**, 17-C, 13th Commercial Street, Phase II (Ext), D. H. A, Karachi, Pakistan for providing Class Value Added Registered Service as mentioned in "Class Value Added Services Licensing and Registration Regulations 2007" to:

- Extend **SMS Aggregator Services** to all, in a non-exclusive manner, free of all discriminations;
 - Abstain from providing any telecom service without obtaining prior license;
 - Promptly provide all information, as and when desired by the Authority, which helps it to quantify proliferation of the technologies or services whether technical, regulatory or financial in nature;
- This registration is valid for a maximum period of five (5) years from 22 June, 2017. In case licensee wants to continue the licensed operations beyond five (5) years, a fresh application for registration may be submitted to the Authority in accordance with Regulation (6) three(3) months prior to the completion of expiry of five years period.
 - In case of allocation of numbering resource(s), **Symmetry Group (Pvt.) Limited** shall pay the fees promptly and shall be liable to pay a penalty @2% per month or part thereof on the amounts outstanding if the dues are not paid by 31st July each year.
 - Symmetry Group (Pvt.) Limited** shall provide registered services in accordance and in compliance with the laws of the Islamic Republic of Pakistan.
 - Symmetry Group (Pvt.) Limited** shall, in the course of provision of its services in the country, comply with the provisions of the Pakistan Telecommunication (Re-organization) Act 1996, the Rules/ Regulations framed there under and directions of the Authority, which may be issued from time to time.
 - Where the provision of this permission is silent or ambiguous, on any issue irrespective of its nature, the Authority's decision shall be final and binding.

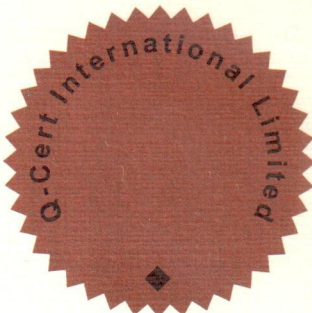

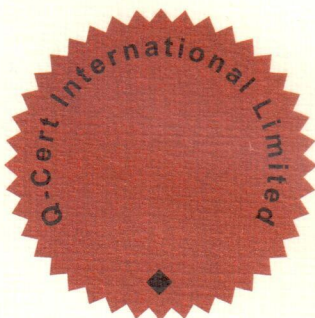
